

# Rezon

## Terms of service

1. The terms of service apply to all Rezon products.
2. Rezon creates services for creation, maintenance and development of Rezon users social connections.
3. Rezon may collect, store, analyze, and use information about users and user-generated (uploaded) content for purposes of improving the quality of Rezon's services.
4. Rezon does not sell or share with third parties user information, personal user data, or any other information by which users can be identified.
5. Rezon displays advertisements of the advertisers' to the audience that was specified by the advertiser as the target audience.
6. The Rezon services use the cryptocurrency Rezon stable token (RZC).
7. The service encourages public activity of users who create popular public content by awarding Rezon Coins to such users.
8. The received or purchased coins may be used by the user for any purpose within the service, including withdrawal in any legal way possible.
9. Rezon user may transfer Rezon coins to another Rezon user, either within or outside the service. If such a transfer is related to the provision of a service, transfer of goods or performance of works, the parties to such a transfer shall act at their own risk.
10. Services provided by Rezon may be paid with Rezon coins.
11. A user, company or community can have only one account on the service. The user, company or community has the right to delete his/her account.
12. Rezon users are not obliged to provide full or truthful information about themselves, except for the minimum necessary information when creating an account. Providing incomplete, inaccurate information by the user may result in improper (inaccurate) operation of the Rezon.
13. Company or community accounts may only be created on the basis of existing personal user accounts. Such individuals are representatives of those companies or communities. If personal accounts of representatives of a community or a company are deleted the corresponding company or community accounts will be deleted automatically no later than 15 days after the last representative account is deleted.
14. Rezon for any reason may not delete an account or limit an access to the account or content.
15. Rezon may warn users that the content they want to access has certain content features (violence, sexual content, profanity, etc.).
16. Users may specify access restrictions to their content or make such access a paid service.
17. Verification with mobile phone number is required to use Rezon coins.
18. Rezon may use user-generated content, and creation (uploading) of user-generated content means that Rezon grants a non-exclusive, royalty-free, worldwide, transferable and sublicensable license to store, use, distribute, modify, launch, copy, publicly perform or display, translate such content and create derivative works based thereon.
19. The user grants permission to Rezon to use the user's name, profile picture and activity information in connection with advertising and sponsored content, including

permission to use the user's name, profile picture and activity information on the Rezon services alongside or in connection with advertisements, offers or other sponsored content that Rezon may display within the service, without compensation to the user.

20. Rezon's services are provided on an "as is" basis and are not guaranteed to be safe, secure, and may have errors or failures.

21. Rezon may change these rules with at least 60 days' notice to users.
